

TERMS OF SERVICE

Last Updated: Feb 6, 2026

These Terms of Service (“Terms”) govern your access to and use of this website (the “Site”), operated by Rush Street Interactive Canada, ULC, and its affiliated entities (collectively “RSI”, “Company”, “we”, “our” or “us”). By accessing or using the Site, you agree to be bound by these Terms. If you do not agree, do not use the Site.

1. Regulatory Status and Purpose of the Site

The Site is intended solely to allow individuals located in Alberta, Canada, to pre-register their interest in RSI’s potential future real-money online gaming platform if and when it receives a license from the Alberta Gaming, Liquor and Cannabis or any successor authority (AGLC) and RSI’s real-money online gaming platform goes live in Alberta.

At this time:

- Real-money online gaming services are not available through the Site;
- No deposits, wagering, betting or gaming activities are offered; and
- The Site is not a gaming platform and is not regulated as such.

Any future real-money gaming services:

- Will only be offered if and when legally permitted
- Will be subject to regulatory approval, including approval by the AGLC
- Will operate under additional terms and conditions, responsible gaming controls, and regulatory requirements

Nothing on this Site constitutes an inducement, invitation or encouragement to gamble.

2. Eligibility and Location Restrictions

By using the Site, you represent and warrant that:

- You are physically located in Alberta, Canada at the time of pre-registration
- You are at least 18 years of age, or the minimum legal age applicable to gaming in Alberta at the time of any future launch
- You are legally permitted to provide personal information for this purpose

Pre-registration submissions from outside Alberta or from individuals under the applicable legal age may be rejected or deleted.

3. No Account Creation or Gaming Relationship

Pre-registration:

- Does not create a gaming account

- Does not establish a customer, player, or wagering relationship
- Does not grant any right to participate in real-money gaming
- Does not guarantee future access, eligibility, or approval

Any future account creation will require, among other things, identity verification, age verification, location verification, and compliance with all regulatory, responsible gaming, and anti-money laundering requirements.

4. Information We Collect

When you pre-register, we may collect:

- Email address
- Date of Birth

We do not collect payment information, government identification, or wagering data through the Site.

5. Use of Personal Information for Regulatory Purposes

Your personal information may be used to record and manage expressions of interest, contact you regarding potential future service availability, conduct preliminary eligibility screening, and comply with legal, regulatory, audit, and reporting obligations.

Where required by law or regulation, we may disclose information to regulatory authorities (including the AGLC), law enforcement or government agencies, and auditors or compliance service providers.

6. Privacy, PIPA Compliance, and Data Safeguards

We collect, use, store, and disclose personal information in accordance with Alberta's Personal Information Protection Act (PIPA) and our Privacy Policy, which is found [here](#).

We maintain reasonable safeguards appropriate to the sensitivity of the information.

7. Consent and Withdrawal

By submitting your information, you provide express consent to the collection, use, and retention of your personal information as described.

8. Responsible Gaming Acknowledgement

You acknowledge that responsible gaming principles will govern any future real-money gaming services and that participation in gaming involves financial risk.

Please play responsibly.

9. Communications and No Promotional Guarantees

Communications related to pre-registration are not gaming promotions. Any applicable incentives, bonuses or inducements shall be governed by the terms applicable to such incentives, bonuses or inducements.

10. No Warranties or Regulatory Guarantees

The Site and pre-registration program are provided “as is” with no guarantees of regulatory approval or launch.

11. Limitation of Liability

To the maximum extent permitted by law, we are not liable for losses arising from use of the Site or the pre-registration program.

12. Changes to Terms and Regulatory Supremacy

Regulatory requirements prevail in the event of any conflict with these Terms.

13. Governing Law

These Terms are governed by the laws of the Province of Alberta and Canada.
